Thank you for your interest in the Annual International Horseradish Festival! After last year's success in its new Uptown Collinsville location. With possible attendance of up to **25,000 visitors**, you are positioned better than ever to showcase your crafts. **APPLICATION DEADLINE: MAY 5, 2023**

The Craft Village will be open Friday - Saturday, June 2<sup>nd</sup> – 3<sup>rd</sup>, 11am – 11 pm; Vendors will be open for business during all hours previously listed unless they are given permission to leave due to inclement weather. Vendors move-in and set-up will be Thursday evening from 6 pm until 10 pm, & Friday before 9 am. Note: All vendors must adhere to set-up schedules due to road / festival closures for safety and security. **Absolutely no vehicles allowed to enter/exit from festival grounds once street closures are in place.**

If you have not participated in the past or if your items for sale have changed, provide two photos of your display and products along with a product description for review by the Festival Executive Committee. The Executive Committee reserves the right to accept vendors and assign spaces.

**The maximum booth size will be limited to 10 x 30. If electricity is required, you must request in advance.** Due to space constraints, limited electricity, and duplicate items, the committee reserves the right to deny application at which time payment and application will be returned. Vendor fees are required to be submitted with this application. Deadline is May 5<sup>th</sup>, 2023, or when the Craft Village is full. INDEMNIFICATION AGREEMENT

This agreement was made by and between the International Horseradish Festival Committee (IHFC), Collinsville Chamber of Commerce, Inc. (CCofC), and (hereinafter Indemnitor):
